- As described in the Fawn Ridge Homeowners Association (HOA) By-Laws, all homeowners must pay the annual recreational facility/pool fees by the due date otherwise access to recreational facility will be denied to anyone residing at that homeowner's address.
- In addition to payment of pool fees, legal proof of residence (i.e. utility bill, etc) and a picture ID are required to obtain a season pass to the recreational facility.
- All residents (homeowners / tenants) must present an appropriate pass with each entry to the recreational facility.
- Children under 13 years of age are forbidden to be in the recreational area without the presence of a responsible adult. The responsible adult must be a resident (member) and cannot be a guest.
- Guests must be accompanied by an adult resident at all times. Members are responsible for their guest's and will be held accountable for their guest's conduct and actions.
- As described in the HOA By-Laws, the recreational facility is a "Common Open Space" (COS) that is to be equally shared by ALL members. This COS is made available to all paid members on a first come, first served basis. No member, tenant, or their guest will be allowed to reserve seating space.
- Splashing is considered a normal pool activity. Please be advised that if you are sitting by the pool, you WILL get wet. If you do not wish to get wet, you should avoid entering the pool and consider sitting further away from the pool area.
- No alcoholic beverages are allowed on the premises. Failure to adhere to this rule will result in denial of entry, immediate ejection from pool and recreational facilities, and possible suspension of pool and recreational facilities privileges.
- The Lifeguards and HOA board members reserve the right to inspect all packages brought on premises. Failure to comply will result in denial of entry and/or immediate ejection from pool and recreational facilities.

I hereby understand the aforementioned and agree to comply with these rules, and the rules and regulations posted at pool side. I further understand that failure to comply with any of these rules and regulations is grounds for immediate ejection from the recreational facility, and upon further review of the HOA board members, suspension of privileges to the facilities, and if appropriate, legal action may be taken against me.
